The Pricing, Data Analysis, and Coding Contractor (PDAC) provides HCPCS assistance to manufacturers to ensure proper coding of Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS). The PDAC has reviewed the above listed product. It is our determination that the Medicare Healthcare Common Procedural Coding System (HCPCS) code to use to bill the four Durable Medical Equipment Medicare Administrative Contractors (DME MACs) is:

L0631 LUMBAR-SACRAL ORTHOSIS, SAGITTAL CONTROL, WITH RIGID ANTERIOR AND POSTERIOR PANELS, POSTERIOR EXTENDS FROM SACROCOCCYGEAL JUNCTION TO T-9 VERTEBRA, PRODUCES INTRACAVITARY PRESSURE TO REDUCE LOAD ON THE INTERVERTEBRAL DISCS, INCLUDES STRAPS, CLOSURES, MAY INCLUDE PADDING, SHOULDER STRAPS, PENDULOUS ABDOMEN DESIGN, PREFABRICATED, INCLUDES FITTING AND ADJUSTMENT

The PDAC provides coding decisions based on the coding guidelines established by the Local Coverage Determination (LCD) and associated policy article(s) developed by the



DME MACs. All products submitted to PDAC for a coding verification review are carefully examined by coders and professionals following a formal, standardized process.

From time to time questions come up internally with the DME MACs and PDAC as to whether a proper coding decision on a product has been made. When such a question arises, the PDAC will re-review the product and render a decision. If the decision is to change the code assigned, the manufacturer of the product is notified by mail. The manufacturer then has the option to ask for a reconsideration, as outlined on our web site.
