## Dear Jim Weber:

The Pricing, Data Analysis, and Coding (PDAC) Contractor has reviewed the product(s) listed above and has approved the listed Healthcare Common Procedure Coding System (HCPCS) code(s) for billing the four Durable Medical Equipment Medicare Administrative Contractors (DME MACs).

The PDAC Contractor provides coding assistance to manufacturers to ensure proper coding of Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS). The PDAC publishes coding decisions based on the coding guidelines established by the Local Coverage Determinations (LCDs) and associated Policy Articles and any related Advisory Articles established by the DME MACs. All products submitted to the PDAC for a coding verification review are examined by coders and professionals following a formal, standardized process.

The PDAC has reviewed the above listed product(s). Based on this review and application of DME MAC policy, the HCPCS code(s) listed below should be used when billing the DME MACs:

L3923 - HAND FINGER ORTHOSIS, WITHOUT JOINTS, MAY INCLUDE SOFT INTERFACE, STRAPS, PREFABRICATED ITEM THAT HAS BEEN TRIMMED, BENT, MOLDED, ASSEMBLED, OR OTHERWISE CUSTOMIZED TO FIT A SPECIFIC PATIENT BY AN INDIVIDUAL WITH EXPERTISE

HCPCS code L3807 is for a wrist, hand, finger orthosis. In order to restrict motion in the wrist, hand and fingers, these devices need to encompass the radius, ulna, carpals, metacarpals and middle phalanges.

The product submitted for review does not immobilize, support or restrict motion of the ulnar and radius (wrist). The product submitted allows for sideways motion and bending of the wrist.



Per the Product Description Sheet, the orthosis "provides a way to brace fingers in extended position while keeping index finger and thumb free". Therefore, HCPCS code L3923 is the most appropriate code.

This decision applies to the application we received on December 29, 2015. If information submitted in that application has changed or were to change, it could impact our decision. Therefore, a new application would need to be submitted for HCPCS coding verification review. The coding assigned in this decision letter will be available on the Product Classification List (PCL) on the Durable Medical Equipment Coding System (DMECS) within ten (10) working days from the letter's date. The DMECS can be accessed on the PDAC website, <a href="www.dmepdac.com">www.dmepdac.com</a>. Please take the time to verify that this coding decision is correctly reflected in DMECS.

If you disagree with this decision, you may request a reconsideration within 45 days of the letter's date and provide evidence to substantiate a reconsideration of PDAC's original coding determination. To request a reconsideration, complete the Reconsideration Request form located on the PDAC website at <a href="https://www.dmepdac.com/review/requesting.html">https://www.dmepdac.com/review/requesting.html</a>. If your request for a reconsideration is made after the 45-day time frame, it will require a new application and documentation to support the request.
